As previously disclosed in our Quarterly Report on Form 10-Q for the period ended September 30, 2022, Flowserve Corporation (the "Company") experienced operational interruptions related to the implementation of a new enterprise resource planning system at one of our manufacturing sites and certain of our North America quick response centers during the third quarter of 2022. The Company is unable to file its Annual Report on Form 10-K for the year ended December 31, 2022 within the prescribed time period without unreasonable effort and expense because additional documentation, testing and assessment of the impact to the Company's internal controls related to this system implementation are needed and this was not discovered until late in the Company's close process. The Company expects to file its Form 10-K on or before the fifteenth calendar day following the prescribed due date.
