The performance rights vest at a rate between 0% and 200% and are based on three factors measured over a two-year performance cycle beginning on January 1, 2019 and ending on December 31, 2020 which are: 1) the issuer's operating income growth over the performance cycle; 2) the Flow Control Division's operating income growth over the performance cycle; and 3) the Flow Control Division's revenue growth over the performance cycle. The performance rights may be settled, at the issuer's discretion, in cash or shares of common stock.
